With reference to your letter cited above, further to the inspection of your firm by the Director of Boilers, Tamil Nadu, Chennai-5 on 04.01.2014, your firm is hereby approved to manufacture Ball valve & Gate Valve of sizes upto 12" with pressure class upto 600 under the purview of Indian Boiler Regulations, 1950.

You are requested to submit the designs and strength calculations for the valves and get the approval from this office before manufacture.

You are advised to qualify your welder for Plate welding under Indian Boiler Regulations, 1950.

All construction should be done as per Indian Boiler Regulations and strictly under the inspection of the Directorate of Boilers.

The Forgings / Castings should be procured along with proper test certificates issued under Indian Boiler Regulations from forge shops / foundries approved under Indian Boiler Regulations 1950.

Castings / Forgings should be procured only as per the drawing approved by the Director of Boilers, Tamil Nadu.

You are requested to remit a sum of Rs.2000/- (Rupees Two Thousand Only) towards the firm registration fees and send the Original Treasury Chalan to this office immediately.

You are also informed that you should always have welders qualified under Indian Boiler Regulations, 1950 for plate welding with valid certificates, for considering firm registration renewal.
